Reclassification of shareholding of Parag Jayantilal Shah, P J Shah HUF & Harsha Parag Shah from Promoter/Promoter Group to Public Shareholder:

Attention of Board was drawn for the request letter received from Parag Jayantilal Shah, P J Shah HUF & Harsha Parag Shah, Promoter Group of the Company on 07th September, 2022 to reclassify their shareholding from "Promoter Group Category" to "Public Category". The Board perused the request letter received from Parag Jayantilal Shah, P J Shah HUF & Harsha Parag Shah.

The Company intimated about the same to BSE Limited on 07th September, 2022.

The Board was briefed that Parag Jayantilal Shah, P J Shah HUF & Harsha Parag Shah are not engaged in the management of the day to day affairs of the Company.

Board also noted the declarations made by Parag Jayantilal Shah, P J Shah HUF & Harsha Parag Shah wherein they are satisfying all the conditions as specified in sub-clause (i) to (vii) of clause (b) of sub-regulation (3) of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) (Sixth Amendment) Regulations, 2018 and shall continue to comply with conditions mentioned in Regulation 31A post reclassification from "Promoter & Promoter Group" to "Public".

It was also briefed that as per SEBI (Listing Obligations and Disclosure Requirements) (Second Amendment) Regulations, 2021 where the promoter(s) seeking reclassification and persons related to the promoter(s) seeking reclassification, together, do not hold more than one percent of the total voting rights in the listed entity, the requirement for seeking approval from shareholder has been done away.
